SPIRITUAL LIVES OF LEADERS

Leadership today demands more than sound judgment and technical expertise. Senior leaders are increasingly confronted with ethical dilemmas, questions of identity, and the tension between performance pressures and inner values. In such contexts, leadership decisions are shaped not only by strategy and logic, but by the inner life of the leader.

Spiritual Lives of Leaders invites senior professionals to step back and reflect on the deeper foundations of their leadership—purpose, presence, and moral responsibility. Drawing on Islamic spiritual traditions and contemporary organisational realities, the programme provides a structured space for leaders to explore how spirituality and compassion can meaningfully inform leadership behaviour, decision-making, and workplace relationships.

Through guided reflection, life-story vignettes, short cases, and facilitated dialogue, participants will examine the balance between the heart and the head, between justice and compassion, and between ambition and service. The programme supports leaders in translating spiritual values into practical leadership practices, while preparing them to lead with greater clarity, humility, and intention—particularly in the lead-up to spiritually significant periods such as **Ramadan**.

This programme is designed for:

- Senior leaders, executives, and professionals in corporate, banking, financial, and mission-driven organisations.
- Leaders with 5+ years of professional experience, particularly those with people-management, mentoring, or organisational influence responsibilities.
- Executives seeking to align professional leadership with spiritual purpose, ethical responsibility, and compassionate influence.

DISCOUNT POLICY

If more than two executives from the same organisation participate (up to a group size of 5 participants), each additional participant after the first two gets a 20% discount on the programme fee.

SUBSTITUTES/TRANSFERS AND REFUNDS

If you are unable to attend a registered course, we will accept a substitute until 2 working days before the programme. Substitute candidates will be subject to the same selection process as the original one. If you wish to cancel your name from a programme, please notify in writing or on call at least 5 working days before the programme. In case of late cancellation, the course fee will be refunded after deducting an application processing fee of PKR 40,000.

It is possible to transfer the deposited fee to any open enrolment programme within 3 years. Transfers should be notified at least 5 working days before the programme. In case the participant or sponsoring organisation fails to utilise the funds within 3 years, the deposited fee will be forfeited.

Note: REDC may cancel or postpone a programme due to insufficient enrolment or unforeseen circumstances.
